Food Bank:

In 2018, FamilyWorks distributed over 246 tons of nutritious food through the Food Bank to 3507 individuals and 2438 households. There were 37830 visits to the food bank, and 2009 deliveries of groceries to 173 homebound individuals. In addition, the Food Bank provided 1648 backpacks filled with healthy meals to area students facing food-insecure households on the weekends and 2340 SnackPacks to children residing at Mary's Place Family shelter in North Seattle. Evening hours were added at the Greenwood Food Bank.

Resource Center:

1,667 individuals participated in our family resource center programs including parenting classes and workshops, parent/child programs and field trips, computer tutoring, and employment counseling. 597 volunteers contributed 9116 hours in our food banks and family resource center. Family Advocates provided 423 instances of one-on-one assistance and support, in English and Spanish. 22 young parents participated in the Teen Parent Program and gained connection to resources, parenting and life skills and essential family resources.
